RESOLUTION OF THE JOINT BOARD OF DIRECTORS OF THE

ELKHART AND ST. JOSEPH COUNTIES HEAD START CONSORTIUM AUTHORIZING EXECUTIVE DIRECTOR TO HANDLE WORK DISRUPTION FOR EMPLOYEES IMPACTED BY CORONAVIRUS

WHEREAS, the Novel Coronaviris (COVID-19) is impacting our region, state, and nation;

WHEREAS, the Joint Board will cooperate with the Elkhart and St. Joseph Counties Health Departments, the Indiana State Department of Health, and the U.S. Center for Disease Control in addressing the spread of COVID-19 to and through our community;

WHEREAS, employees of the Elkhart and St. Joseph Counties Head Start Consortium may have regular hours or work reduced or disrupted and the Joint Board desires to authorize the Executive Director to review the salary, wage, and wage-related fringe-benefit aspects of any disruption and act as necessary to provide assistance to impacted employees;

WHEREAS, in a publication issued on March 13, 2020, the Office of Head Start provided grantees additional flexibility in addressing the hardships caused by COVID-19 and directed grantees to continue to pay wages and provide benefits to staff who are unable to report to work during program closures necessary to address COVID-19;

NOW, THEREFORE, BE IT RESOLVED that the Joint Board directs the Executive Director to review the salary, wage, and wage-related fringe-benefit aspects of any disruption, including program closures;

BE IT FURTHER RESOLVED that the Joint Board authorizes the Executive Director to take any actions they deem appropriate and necessary to mitigate the impact any program closure has on salaries, wages, and wage-related fringe-benefits of Consortium employees;

BE IT FURTHER RESOLVED that the Joint Board authorizes the Executive Director and her administrative team to take any other measures the Executive Director deems necessary to assist employees as a result of other circumstances related to COVID-19; and

BE IT FURTHER RESOLVED that the Executive Director of the Elkhart and St. Joseph Counties Head Start Consortium is hereby authorized to take all actions necessary or desirable to carry out the intent of this resolution.
